





- ▶ 9 of the world’s top 10 Medical Technology Companies such as Boston Scientific & Medtronic
- ▶ 8 of the top pharma/bio companies such as Pfizer & Amgen
- ▶ 10 top ‘Born on the Internet’ companies such as Google & Facebook
- ▶ 3 of the top 5 games companies such as EA & Activision



## • *Taxation*

Almost 1,000 multinational companies have chosen Ireland as their strategic European base due to our pro business environment and attractive taxation rates:

- ▶ Ireland has the lowest corporation tax rate in Europe at 12.5%.
- ▶ Companies can avail of a 25% tax credit against research & development costs.
- ▶ Ireland has double taxation agreements with over 60 countries including every major trading partner.

## • *Ireland is a member of the European Union and the Eurozone*

According to the IMF (International Monetary Fund) the economy of Europe is the largest and most affluent economy in the world. The Euro is the official currency of the Eurozone and is used daily by 332 million Europeans. The Euro is the most traded currency in the world after the US Dollar and Ireland is the only English speaking country in the Eurozone.
